A BILL

To require the Secretary of Transportation to issue a rule requiring all new passenger motor vehicles to be equipped with a child safety alert system, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Helping Overcome
5 Trauma for Children Alone in Rear Seats Act” or the
6 “HOT CARS Act of 2016”.

1 **SEC. 2. CHILD SAFETY ALERT SYSTEM RULEMAKING.**

2 (a) **RULE REQUIRED.**—Not later than 2 years after
3 the date of enactment of this Act, the Secretary shall issue
4 a final rule requiring all new passenger motor vehicles be
5 equipped with technology to provide an alert that a child
6 or unattended passenger remains in a rear seating position
7 after the vehicle motor is deactivated.

8 (b) **EFFECTIVE DATE OF RULE.**—The regulation
9 issued by the Secretary under this section shall take effect
10 1 year after the date of the publication of the final rule.

11 (c) **REPORT TO CONGRESS.**—Not later than 1 year
12 after the date of enactment of this Act, the Secretary shall
13 issue a report to the Committee on Commerce, Science,
14 and Transportation of the Senate and the Committee on
15 Energy and Commerce of the House of Representatives
16 on the feasibility of retrofitting existing passenger motor
17 vehicles with technology to provide an alert that a child
18 or unattended passenger remains in a rear seating position
19 after the vehicle motor is deactivated.

20 (d) **DEFINITIONS.**—In this section:

21 (1) **ALERT.**—The term “alert” means a signal
22 that may be auditory or visual (or both) that will
23 provide an effective warning to the driver of the pas-
24 senger motor vehicle that a child or unattended pas-
25 senger remains in a rear seating position after the
26 vehicle motor is deactivated.

1 (2) PASSENGER MOTOR VEHICLE.—The term
2 “passenger motor vehicle” has the meaning given
3 that term in section 32101 of title 49, United States
4 Code.

5 (3) REAR SEATING POSITION.—The term “rear
6 seating position” means any designated seating posi-
7 tion that is rearward of the front seat.

8 (4) SECRETARY.—The term “Secretary” means
9 the Secretary of Transportation.
